1 TERMS & CONDITIONS FOR WARRANTY OF NUVO ENERGY NE-GIK-XXX PRODUCTS

By using the product, you accept the following terms and conditions:

1.1 LIMITED WARRANTY

Nuvo Energy warrants that its NE-GIK-XXX Product and/or genuine add-on devices ('Goods' and 'Add-On Goods') are free from defects in material and workmanship, according to the following terms and conditions:

- The limited warranty for all genuine NE-GIK-XXX products and devices extends for the first twelve (12) months beginning on the date of purchase of the product.
- II. The limited warranty extends only to the original purchaser ('Buyer') of the Product. It is not assignable or transferable to any subsequent purchaser / end user.
- III. During the limited warranty period, Nuvo Energy or its authorized service centres will repair or replace, at option, any defective products, or parts thereof with new or factory rebuilt replacement items and return the product to the customer in working condition. Customer will not be required to pay for either parts or labour in repairing or replacing the product provided such defects are covered under the terms and conditions of this limited warranty. Nuvo Energy reserves the right to retain any part(s) or component(s) replaced, at its discretion, in the event of a defect noticed in the equipment.
- IV. Warranty claim expenses relating to deinstallation, reinstallation or transport to Nuvo Energy or its authorized service centres, is at the customer's expense. If Nuvo Energy or its authorized service centre deems a warranty claim to be valid claim, the transport costs of a new or repaired system will be at Nuvo Energy's expense.
- V. Repaired Product will be warranted for the balance of the original warranty period. Moreover, the time taken for repair/replacement and in transit whether under the warranty or otherwise shall not be excluded from the warranty period.
- VI. The external housing, enclosure and cosmetic parts shall be free of defects at the time of shipment and, therefore, shall not be covered under these limited warranty terms.
- VII. Upon request from Nuvo Energy or any authorized service centre, the Buyer must provide a purchase receipt or other information to prove the date and place of purchase.

1.2 EXTENDED WARRANTY

Nuvo Energy may offer the Buyer, at its discretion and at an additional cost, the option to extend the limited warranty of the NE-GIK-XXX Goods.

While this would affect the duration of the warranty, the terms set forth remain as per the limited warranty and shall not be altered in any manner. The warranty violations will remain the same as well.



1.3 WARRANTY TERM CONDITIONS

This Warranty will not be applicable in any of the following circumstances:

- I. Defects or damages resulting from use of the Product in other than its normal and instructed manner, as determined by the authorized service centre / Nuvo Energy personnel.
- II. Warranty shall be void if the Product has failed due to defects or damages from abnormal use, abnormal conditions, improper storage, exposure to moisture or dampness, unauthorized modifications, unauthorized connections, unauthorized repair, misuse, neglect, abuse, accident, alteration, improper installation, or other acts which are not the fault of Nuvo Energy, including damage caused by dropping, blown fuses, voltage surges, spills of food or liquid.
- III. Products which have had their original serial number removed, obliterated, or altered in any way.
- IV. Defects due to causes beyond control like lightening, abnormal voltage, natural calamities, or Acts of God, or while in transit to the service centre.
- V. Defects or malfunctions of the product not notified by Buyer during the warranty period.
- VI. Damage resulting from use of non Nuvo Energy-approved accessories.
- VII. Warranty does not cover the normal wear and tear of all plastic or metal surfaces and all other externally exposed parts.
- VIII. Warranty does not cover any third-party accessories such as micro SD cards, batteries, power adapters and cables. Nuvo Energy will not be held liable for damage resulting to any devices interfaced with NE-GIK-XXX products.
- IX. Defects caused by household pets, rats, cockroaches, ants, or any other animals or insects.

1.4 LIMITATIONS OF LIABILITY
